

Lieutenant General Mike Plehn is the 17<sup>th</sup> President of the National Defense University. As President of NDU, he oversees its five component colleges that offer graduate-level degrees and certifications in joint professional military education to over 2,000 U.S. military officers, civilian government officials, international military officers and industry partners annually.


Raised in an Army family, he graduated from Miami Southridge Senior High School in 1983 and attended the U.S. Air Force Academy Preparatory School in Colorado Springs, Colorado. He graduated from the U.S. Air Force Academy with Military Distinction and a degree in Astronautical Engineering in 1988. He is a Distinguished Graduate of Squadron Officer School as well as the College of Naval Command and Staff, where he received a Master's Degree with Highest Distinction in National Security and Strategic Studies. He also holds a Master of Airpower Art and Science degree from the School of Advanced Airpower Studies, as well as a Master of Aerospace Science degree from Embry-Riddle Aeronautical University.

Lt Gen Plehn has extensive experience in joint, interagency, and special operations, including: Middle East Policy in the Office of the Secretary of Defense, the Joint Improvised Explosive Device Defeat Organization, and four tours at the Combatant Command level to include U.S. European Command, U.S. Central Command, and twice at U.S. Southern Command, where he was most recently the Military Deputy Commander. He also served on the Air Staff in Strategy and Policy and as the speechwriter to the Vice Chief of Staff of the Air Force.

Lt Gen Plehn is a master navigator with 2,200 flight hours in the AC-130H, AC-130U, U-28, MQ-1B, MQ-9, and F-16D. He has more than 350 combat hours supporting operations over Bosnia, Somalia, Haiti, Afghanistan, and Iraq. He has commanded special operations units at the squadron, group, and wing levels, and was formerly the Deputy Commander of Air Force Special Operations Command.

His awards and decorations include the Defense Distinguished Service Medal, Distinguished Service Medal, Defense Superior Service Medal with 2 oak leaf clusters, the Legion of Merit, Bronze Star, Defense Meritorious Service Medal with oak leaf cluster, Meritorious Service Medal with 3 oak leaf clusters, Air Medal with 2 oak leaf clusters, Aerial Achievement Medal with 4 oak leaf clusters, Air Force Commendation Medal, Air Force Achievement Medal with oak leaf cluster, the Gallant Unit Citation, and the Medal for Distinguished Service to the Colombian Military Forces.

An Eagle Scout and avid reader, he speaks passable Spanish. In their quiet time, Mike and his wife enjoy watching ice hockey and providing staff assistance to their two cats.





## JOHN M. PAXTON, JR. GENERAL UNITED STATES MARINE CORPS (RETIRED)



### Former Assistant Commandant of the Marine Corps

### **CONUS** and Week 5



John M. ("Jay") Paxton is employed as a Highly Qualified Expert - Senior Mentor for the Joint Staff J7 in support of Combatant Command and Joint Task Force Operations and Exercises. He is also employed as a Senior Fellow for the National Defense University in support of the Pinnacle, Capstone, and Keystone programs. Additional federal government work includes membership on the Board of Trustees for the Institute for Defense Analysis, an FFRDC, where he concurrently serves as a Senior Fellow in support of the Defense Science Study Group.

General Paxton was born in Chester, PA and raised in nearby Broomall. He graduated from Cornell University in Ithaca, NY with a Bachelor of Science (1973) and Master of Civil Engineering (1974). He then attended Officer Candidate School in Quantico, VA and was commissioned a 2<sup>nd</sup> Lieutenant in the United States Marine Corps.

Initial assignments in the operating forces included Rifle and Weapons Platoon Commander and Company Executive Officer in Co. B, 1st Battalion, 3rd Marines followed by Regimental Training Officer for 4th Marines and then Executive Officer, Co. G, 2nd Battalion, 4th Marines. As a Captain he commanded Co. L, 3rd Battalion, 5th Marines. This was preceded and succeeded by service as Battalion Operations Officer. As a Major and LtCol he served as an Operations and Exercise Officer in II MEF and subsequently commanded 1st Battalion, 8th Marines for 27 months. They were redesignated BLT 1/8 and deployed with 22nd MEU in 1993-94 as Landing Force Sixth Fleet in support of stability operations in Bosnia and later as United Nations Quick Reaction Force in Mogadishu, Somalia. Returning to II MEF he served briefly as Deputy G-3 Operations for 2nd Marine Division. As a Colonel, Paxton returned to Camp Pendleton and 1st Marine Division where he was the G-3 Division Operations officer for one year followed by command of 1st Marine Regiment for two years.

His non-fleet tours include Marine Barracks, Washington, DC where he commanded Company B as a Captain and Marine Corps Recruiting Station New York which he commanded for three years as a Major. He served in Plans Division for the Deputy Commandant for Plans, Policies, and Operations as a LtCol. This was followed by a tour as the Executive Assistant and Marine Aide to the Under Secretary of the Navy. Paxton was also designated a Joint Qualified Officer and served initially as Amphibious Operations Officer and concurrently as Executive Officer of the Crisis Action Team at Combined Forces/United States Forces/United Nations Command, Korea.

As a general officer, Paxton served initially as Director, Programs Division, Deputy Commandant Programs and Resources. This was followed by three years as Commanding General of Marine Corps Recruit Depot, San Diego and the Western Recruiting Region. He then assumed command of 1st Marine Division for a year followed by a subsequent year as Chief of Staff for Multi-National Forces – Iraq. He returned to the Joint Staff for just under three years serving most of that tour as J-3, Director of Operations. Returning to the Marine Corps, he assumed command of II Marine Expeditionary Force and Commander Marine Forces Africa. That was succeeded as Commanding General Marine Corps Forces Command, Commanding General Fleet Marine Force Atlantic, and Commander Marine Forces Europe. He was promoted to General on 15 Dec 2012 and served as Assistant Commandant of the Marine Corps until his retirement in August of 2016, completing over 42 years of commissioned service.

General Paxton is a graduate of the U.S. Army Infantry Officer Advanced Course and the Marine Corps Command and Staff College. He also served as a Commandant's Fellow at the Brookings Institute and the Council on Foreign Relations. He lives in northern Virginia with his wife Debbie. They are the proud parents of three adult children.



# PATRICK Z. ALSTON COMMAND SERGEANT MAJOR UNITED STATES ARMY (RETIRED)



### Former Command Senior Enlisted Leader United States Strategic Command

Command Sergeant Major Patrick Z. Alston is employed as a Senior Fellow for the National Defense University's Capstone and Keystone programs. He is also a Senior Consultant with Burlington Capital Corporation, a diverse investment management firm located in Omaha, Nebraska.

CSM Pat Alston is a native of Columbus, Georgia. He is a graduate of Columbus High School. After graduation, he subsequently enlisted into the United States Army where he completed Basic Training at Fort Dix, New Jersey.

His initial assignment was at Fort Belvoir, Virginia, as a Medical Specialist. Subsequent assignments include Medical Specialist with 3rd Battalion, 325th Infantry Regiment, and 82nd Airborne Division. In 1984 he reclassified to the Chemical Corps and was assigned as a squad leader with 4th Chemical Company, 2nd Infantry Division; NBC NCO and Squad Leader with Alpha Company, 3rd Battalion, 73rd Armor, 82nd Airborne Division; Battalion NBC NCO with 3rd Battalion, 73rd Armor, 82nd Airborne Division; Senior NBC Operations and Staff NCO with Division Chemical, 82nd Airborne Division; NBC Operations, Staff NCO and Platoon Sergeant with 34th Support Group, Korea; Senior Drill Sergeant with Alpha Company, 82nd Chemical Battalion; Detachment Sergeant for the Contingency Support Detachment (WHITE HOUSE TEAM), 84th Chemical Battalion, U.S. Army Chemical School; Career Advisor/Branch Manager Career Management Field 74D, Total Army Personnel Command (PERSCOM); First Sergeant for Headquarters and Headquarters Company, Soldier Biological Chemical Command and Technical Escort Unit; Battalion CSM of the U.S. Army Technical Escort Battalion in Edgewood, Maryland; Division Chemical Sergeant Major for the 2nd Infantry Division, Korea; Battalion CSM of the 23rd Chemical Battalion, 19th TSC, Korea; CSM of the 23rd Area Support Group, 19th TSC, Korea; 10th Regimental CSM of the Chemical Corps, Command Senior Enlisted Leader, Defense Threat Reduction Agency/STRATCOM Center for Combating WMD and finished his Army career as the Command Senior Enlisted Leader of United States Strategic Command.

His military schools include Command Sergeant Major Course; Sergeant Major Academy (class # 51); First Sergeant Course (CDMT List); Advanced Noncommissioned Officers Course (Honor Grad); Basic Noncommissioned Officers Course (CDMT List); Primary Leadership development Course (CMDT List); Drill Sergeant School (Honor Grad); Airborne School; Air Assault School (Honor Grad); Technical Escort Course (J5) (Honor Grad); Drill Corporal Course; Customs Course; White House Executive Support Course; Executive Operations Course; Hazardous Material Course (Level 1-5); Chemical Weapons Orientation Course Joint Military Intelligence Course on Chemical Affairs; Assignment Manager/PDNCO Course; Administrative Procedures Course (DA Level), Joint Forces Staff College, United States Army Force Management Course and Keystone Course. He is currently a few classes away from receiving his Bachelors of Science Degree in Leadership with a concentration in Management from Trident University.

As Commander U.S. Naval Forces in Europe and Africa, Admiral Locklear managed the U.S. Navy's relationships with all key navies throughout two continents, developing key partnership capabilities and capacities. To protect U.S. interests abroad and to halt the spread of terrorism in the region he successfully commanded all maritime aspects of Operation Enduring Freedom (OEF) in Europe and Africa. In 2011 in Libya, in response to a UN mandate to protect the Libyan people from the Gaddafi regime, Admiral Locklear designed and led the multinational Joint Task Force (Odyssey Dawn), successfully enforcing the mandate, and then commanded the follow on NATO Operation Unified Protector (OUP) until the final collapse of the Gaddafi regime.

As Commander of NATO's Allied Joint Force Command, he provided operational level command and oversight of NATO's ongoing stability operations in Kosovo and NATO's training mission in Iraq, and was a primary architect of NATO's twenty-first century command structure.

A nuclear qualified surface warfare officer, Admiral Locklear's numerous commands at sea included the US Navy's Third Fleet, USS Nimitz Carrier Strike Group during Operation Iraqi Freedom, Destroyer Squadron Two, and the Spruance class destroyer USS Leftwich (DD 984). Ashore he served as the Director of the Navy Staff, the 78th Commandant of Midshipmen at the US Naval Academy, and head of the Navy programming and assessment divisions where he oversaw the programming of the annual Navy budget of over 125 billion dollars.

Admiral Locklear is a 1977 graduate of the US Naval Academy, a 1992 graduate of the National Defense University's Industrial College of the Armed Forces, and holds a Master's Degree in Public Administration from the George Washington University. He is the recipient of numerous awards and decorations including the Defense Distinguished Service Medal, the Defense Superior Service Medal, Legion of Merit, Bronze Star and decorations from South Korea, Taiwan, the Philippines, Australia and France.





# JOHN F. KELLY GENERAL USMC (RETIRED)

### Former Commander, US Southern Command IPACOM Field Study



General Kelly served as the Commander, United States Southern Command, Miami, FL, from November 2012 until January 2016. He retired from active duty after 45+ years of service to the nation as a United States Marine—both as an enlisted infantryman and infantry officer—on 1 February 2016.

Born and raised in Boston, he enlisted in the Marine Corps in 1970. He was released from active duty as a sergeant of infantry in 1972. Following graduation from the University of Massachusetts (Boston) in 1975, he was commissioned a second lieutenant in the Marine Corps and assigned an infantry occupational specialty. In addition to attaining an MA degree from Georgetown University in National Security Affairs (1984), and an MS from the National Defense University in National Security (1995), his formal military education includes The Basic School (1976), the U.S. Army's Advanced Infantry Officer's Course (1981), the Marine Corp's Command & Staff College (1991) and School for Advance Warfighting (1992), the National War College (1995), Capstone (2004), Joint Force Land Component Commander Course (2006), and Joint Flag Officer Warfighting Course (2007).

In his many assignments to the Fleet Marine Force as a company and field grade officer, General Kelly qualified in various infantry battalion staff assignments as well as commanding a number of infantry platoons and companies. He also commanded the 1<sup>st</sup> Light Armored Vehicle Battalion (LAR), Camp Pendleton, CA, as a major and lieutenant colonel. Finally, during formative years he was a proud "sea going" Marine serving aboard the aircraft carriers Forrestal and Independence (1979-1980).

General Kelly was also a trainer and an educator at The Basic School, Quantico, VA, first as the head of the Offensive Tactics Section, Tactics Group, and later as the Director of the Infantry Officer Course (1987-1990). After three years of instructing, shaping and mentoring some of the very finest young men and women this country produces to be Marine Officers, he then attended the Marine Corps Command & Staff College and the School for Advanced Warfare, both located at Quantico (1990-1992).

After completing two years in command of 1st LAR (1992-1994) and duty under instruction at the National War College, he was selected by the Commandant of the Marine Corps to serve as his personal liaison to the U.S. House of Representatives, Capitol Hill (1995-1999). Promoted to colonel while on the Hill he next served on joint duty as the Special Assistant to the Supreme Allied Commander (Generals Clarke & Ralston), Europe, Mons, Belgium.

Returning to the U.S in 2001 he was assigned to a third tour of duty at Camp Lejeune, now as the Assistant Chief of Staff for operations (G-3) with the 2<sup>nd</sup> Marine Division. Then the Trade Towers and pentagon were attacked. Selected for brigadier general that year he was transferred for duty with the 1<sup>st</sup> Marine Division as the assistant division commander assisting the commanding general in preparing the unit for the war we knew was coming. The majority of the two years with the division (2002-2004) was spent fighting in Iraq most notably participating in the "March Up" to Baghdad, then as Commander, "Task Force Tripoli," that liberated the Baghdad – Tikrit – Baiji corridor of operations, then back with the division main executing counterinsurgency operations in al Anbar Province including the cities of Fallujah, Ramadi, Hit, Rawah, and al Qaim.

Returning home from the war zone General Kelly was assigned duties as the Legislative Assistant to the Commandant of the Marine Corps, and Deputy Assistant Legislative Assistant to the Secretary of the Navy (2004-2007). During this time in the pentagon General Kelly was promoted to major general and returned to Camp Pendleton, CA. He now assumed duties as the Commanding General, I Marine Expeditionary Force (Forward) deploying back to Iraq in early 2008 for a 12+ month tour in the west (al Anbar and western Ninewa Provinces). Almost immediately after his return in 2009 General Kelly was nominated, confirmed by the senate, and promoted to lieutenant general. He was privileged to take command of Marine Forces Reserve and Marine Forces North, New Orleans, LA (2009-2011). A second assignment as a lieutenant general brought him back to the pentagon as the Senior Military Assistant to Defense Secretaries Gates and Panetta until October 2012. Again confirmed for promotion he was subsequently promoted to the rank of general assuming command of United States Southern Command on November 19, 2012. General Kelly relinquished command on 12 January 2016 and transferred to the retired list on 1 February.

On 20 January 2017, having been previously confirmed by the U.S. Senate for the position, he assumed duties as the Secretary, Department of Homeland Security. On 31 July 2017 Secretary Kelly was asked by the president to assume the duties of the White House Chief-of-Staff, a position he held until January 2019.



## THOMAS D. WALDHAUSER GENERAL UNITED STATES MARINE CORPS (RETIRED)



### Former Commander United States Africa Command



### **ARICOM Field Study**

Thomas Waldhauser is employed as a Senior Fellow for the National Defense University in support of the Pinnacle, Capstone, and Keystone programs.

A native of South Saint Paul, Minnesota, General Thomas D. Waldhauser (Ret.) was commissioned in 1976 as an Infantry Officer in the U.S. Marine Corps. Throughout his 43 years of military service, General Waldhauser has led at all levels, including Commanding Officer of 15th Marine Expeditionary Unit (SOC); Commanding General USMC Warfighting Lab; Deputy Commander USMC Combat Development Command; Chief of Staff, U.S. Special Operations Command; Commanding General, First Marine Division; and Deputy Commandant for Plans, Policies, and Operations at Headquarters Marine Corps. He has participated in Operation Desert Storm, Desert Shield, Enduring Freedom, and Iraqi Freedom.

As the Commanding General for both I Marine Expeditionary Forces (I MEF) and U.S. Marine Forces Central Command 1 (MARCENT), General Waldhauser led both wide-ranging organizations simultaneously, and was the last general officer to do so before the role was restructured into 2 separate general officer billets.

He was then selected to serve as Senior Military Assistant to the Secretary of Defense, operating in a highly trusted capacity to advise and shape policies and operational strategies impacting the entire DoD organization.

Subsequently, General Waldhauser was appointed Director of Joint Force Development (J7) for the Joint Chiefs of Staff. During his tenure at the J7, General Waldhauser led the development of joint operations strategies and partnered with U.S. congressional members to develop the Goldwater-Nichols Act Reform.

Prior to retiring from the military in 2019, General Waldhauser was the Combatant Commander for U.S. Africa Command (AFRICOM), where he led all aspects of U.S. security operations across the entire continent of Africa, spanning 53 nations. In this role, General Waldhauser developed overarching strategies to promote defense, diplomacy, and development throughout the region. Often working with African-nation Presidents and senior officials, General Waldhauser cultivated relationships supporting allied nations while solidifying the U.S. as a preferred partner.

General Waldhauser's post-military career includes a position on the Board of Governors for the Marine Corps Heritage Foundation, as well as his position as a Fellow at National Defense University where he assists with the CAPSTONE course for newly promoted Brigadier Generals and Rear Admirals.

General Waldhauser is a graduate of Bemidji State University and the National War College with an MS in National Security Strategies. His military awards include Defense Superior Service Medal (x3), Legion of Merit with Valor, Bronze Star, Meritorious Service Medal (x4), Navy Achievement Medal (x2), and a Combat Action Ribbon.

### **EUCOM** Field Study



Tod D. Wolters, Gen (ret), USAF

In 2022, General Tod Wolters completed a distinguished 40-year active-duty career in the US Air Force as the Supreme Allied Commander Europe (SACEUR) and Commander US European Command


(EUCOM). As the SACEUR: he led Europe's transition out of Afghanistan; ensured the COVID health crisis did not transform to a security crisis; and, led NATO's military Allies and Partners through the largest invasion of a European nation since WWII. He united military activities alongside leadership of all 30 NATO member nations and was instrumental in advancing the future transition of Sweden and Finland to NATO. In addition to commanding all European military forces, General Wolters worked closely with Presidents, Ambassadors, and Chiefs of Defense to improve nation's ability to defend and generate peace. His comprehensive approach dramatically improved the security disposition of the European continent.

Prior to General Wolters leadership position at NATO and EUCOM, he served as the Commander, US Air Forces Europe, Commander US Air Forces Africa, Commander NATO Allied Air Command and Director Joint Air Power Competence Center from 2016 to 2019. General Wolters has also served as the Director of Operations of the US Joint Staff, Director of Operations of the US Air Force, Commander 12<sup>th</sup> Air Force/Air Component Command US Southern Command, Director of Legislative

Liaison/US Air Force, Deputy Commander of US and NATO Air Forces Afghanistan, Director of Operations US Air Force Space Command and as a Deputy Commander for Combined Security Assistance Command Afghanistan.

Additionally, General Wolters served in key leadership positions at the tactical, operational and strategic levels of the United States military. These positions included command of three Tactical Air Wings, a Fighter Group, a Fighter Squadron and staff positions at USAF Headquarters and US Pacific Command. General Wolters has fought and commanded during Operation Desert Storm, Iraqi Freedom, Enduring Freedom (Afghanistan) and Southern Watch (Irag). General Wolters awards and decorations include the Defense Distinguished Service Medal, the Distinguished Service Medal, the Defense Superior Service Medal, the Legion of Merit, the Bronze Star and the Air Force Meritorious Service Medal. Additionally, General Wolters has over 5000 flight hours primarily in the F-15C, F-22, OV-10, T-38 and A-10 aircraft.

General Wolters graduated from the US Air Force Academy in 1982. His military education includes the US Air Force Fighter Weapons School, Air Command and Staff College, Armed Forces Staff College and the US Army War College. General Wolters holds masters degrees from Embry-Riddle Aero University and the US Army War College. Additionally, General Wolters was a Senior Executive Fellow, John F. Kennedy School of Government, Harvard University.



### Gerard "Gerry" M. Mauer, Jr. Director Capstone, Keystone, Pinnacle

Rear Admiral Mauer retired from the Navy in March 2008 after over 31 years of service, which included extensive experience in fleet operations, resource management, technical innovation, Joint Professional Military Education (JPME), interagency coordination, and leading organizational change in NATO and joint commands.

From 2008 to 2011, RADM Mauer was a Group Vice President for Sabre Systems Inc. He was responsible for developing then implementing the corporate strategic plan and managing the Southeast Region's profit and loss operations, its contracts, corporate business development, human resources programs, and Capability Maturity Model Integration (CMMI) level III attainment. After leaving Sabre Systems, RADM Mauer had positions as an



Associate with Burdeshaw Associates, as a Senior Analyst for Wikistrat, as a Board member and Board Tresurer for the Navy Safe Harbor Foundation, and as a representative and the national Co-Chair for the US Global Leadership Coalition's Veterans for Smart Power.

Admiral Mauer's last position in the Navy was from 2006 to 2008, when he served as the Commandant, Industrial College of the Armed Forces (ICAF). He was responsible for executing the congressionally mandated and accredited master's degree senior Professional Military Education curriculum. As a university leader, he directly supported the direction of the National Defense University and was a key member in the development of the University's strategic plan.

From 2003 to 2006, he served as the NATO Allied Command Transformation's Director, Joint Experimentation, Exercises, and Assessment, where he developed and implemented NATO's largest Concept Development and Experimentation program. The scope included creating NATO's transformation strategic vision and aligning the vision with its concepts and requirements. As a result of his initiatives, NATO rapidly implemented new processes, policies, and systems in support of its forces in Afghanistan and Iraq as well new capabilities to support its political and military infrastructure in NATO headquarters.

From 2001 to 2003, he was the Deputy, Directorate for Information Operations (J39/DDIO), Joint Staff Director of Operations (J-3) where he was responsible for direct coordination with the Office of the Secretary of Defense staff, Combatant Commands, and interagency organizations in their global information operations. In this capacity, his responsibilities also included supervision and operational coordination of the Joint Staff's Special Technical Operations information system and its programs.

Admiral Mauer graduated from Villanova University and the Naval Postgraduate School. He was a Naval Aviator who commanded Helicopter Antisubmarine Squadrons SEVEN (HS-7) and TEN (HS-10) in addition to assignment as the Commanding Officer of USS NASSAU (LHA 4). He has vast experience at sea with deployments to the Atlantic Ocean, Mediterranean Sea, and Arabian Gulf. Ashore assignments included: Naval Postgraduate School student, Assistant Program Manager for the Naval Air Systems Command SH-60F/H helicopter program (PMA 266), and Training Officer and Instructor Pilot in Helicopter Antisubmarine Squadron ONE (HS-1). He started with Capstone in August of 2016.

### Bonnie J. Swanson Deputy Director Capstone, Keystone, Pinnacle



Bonnie Swanson is a native of Ellington, CT and a graduate of Ellington High School. After her freshman year at the University of Connecticut, she enlisted in the USMCR. Upon completing recruit training at Parris Island, SC, Bonnie returned to UCONN to continue her studies and reserve service with 6th Motor Transport Battalion, Providence, RI. In 1988 she graduated from UCONN with a Liberal Arts degree (Sociological and Educational Behavior Development) and accepted her commission in the USMC. After completion of The Basic School in 1989 and her assignment as a Military Police Officer, Bonnie reported to MCAS Cherry Point, NC for duty as a Platoon Commander and Services Officer.


In 1992, Bonnie was assigned as the Operations Officer for Recruiting Station, Baltimore, MD. Serving as an OpsO for 3 years, Bonnie was selected as the 4th Marine Corps District Contact Team Officer, Harrisburg, PA. Leading a team of three Master Gunnery Sergeants, the Contact Team trained over 350 recruiters and command group members within a 7 state area.

In 1997 Bonnie received orders to MCB, Camp Lejeune, NC as the Operations Officer, Provost Marshal's Office. She simultaneously served as the Commanding Officer, Military Police Company (330+ Marines) during this tour.

In January of 2001, Bonnie was hired by the National Defense University as the Executive Officer of Capstone. Over the years her position has evolved into the Deputy Director of Pinnacle (3 star course), Capstone, and Keystone (Command Senior Enlisted course).


He has commanded the Royal Australian Navy Recruit School and the ANZAC Class Frigates *Warramunga* and *Stuart*.

BG James K. Dooghan assumed duties as Deputy, The Inspector General July 17, 2023.

He was previously the Deputy Commanding General for Maneuver with the 4<sup>th</sup> Infantry Division, Fort Carson, Colorado from July 2021 to June 2023.

BG Dooghan was a distinguished military graduate and commissioned as a Second Lieutenant in Armor from Portland State University (PSU), Oregon in December 1992. He then served as the commander of 4th Battalion, 9th Infantry Regiment at JBLM, and the Horn of Panjwa'i, Afghanistan (OEF 12-13). BG Dooghan then served as the G-5 for the 7th Infantry Division. Following the U.S. Army War College, Dooghan served as the Task Force Marne (3rd Infantry Division-Rear) chief of staff, then commanded the 2nd Brigade "Spartans," 3rd Infantry Division, at Fort Stewart, Georgia.

Following brigade command, he served as the executive officer to the commander of Resolute Support. He redeployed and became a survivor of a craniotomy, and subsequently was selected to serve as the first commander of 4th Security Forces Assistance Brigade at Fort Carson.






# **BG Frank J. Lozano**


