



# **Washington Treaty – 1949 – Article 2**


- The Parties will contribute toward the further development of peaceful and friendly international relations by strengthening their free institutions, by bringing about a better understanding of the principles upon which these institutions are founded, and by promoting conditions of stability and well-being.**

# NATO Treaty, Article 4

- **The Parties will consult together whenever, in the opinion of any of them, the territorial integrity, political independence or security of any of the Parties is threatened.**

Article 4 has been invoked seven times since the alliance's founding in 1949, five times by Turkiye, once by Poland (2014) regarding RU invading Crimea, Ukraine, and the most recent, Feb 24, 2022, by eight Allies regarding the further Russian invasion of Ukraine.

(Bulgaria, Czechia, Estonia, Latvia, Lithuania, Poland, Romania and Slovakia.)





**NATO Washington Treaty  
1949**

**Art. 5, Paragraph 1**

**Invoked 9/12/2001**

The parties agree that an armed attack against one or more of them in Europe or North America shall be considered an attack against them all, and consequently they agree that, **if such an armed attack occurs, each of them**, in exercise of the right of individual or collective self-defense recognised by Article 51 of the Charter of the United Nations, **will assist the Party or Parties so attacked by taking forthwith, individually, and in concert with the other Parties, such action as it deems necessary**, including the use of armed force, to restore and maintain the security of the North Atlantic area.

## Sweden's NATO bid passed its final obstacle

Hungary's Parliament voted today (Feb.26) to accept Sweden as a new member of NATO,

clearing the final hurdle that had long held up the expansion of the military alliance. The approval sealed a major shift in the balance of power between the West and Russia set off by the war in Ukraine.

The vote followed a decision by Sweden to provide Hungary with four Swedish-made fighter jets and a promise that Saab, which manufactures the warplanes, would open an A.I. research center in Hungary. Prime

Minister Viktor Orbán of Hungary, who has maintained cordial relations with President Vladimir Putin, has a long record of using his veto power over key decisions in Europe.





# NATO 2024 BUDGET

Allies agreed NATO's civil and military budgets for 2024 at a meeting of the North Atlantic Council on Wednesday (13 December 2023). The civil budget is set at €438.1 million, and the military budget is set at €2.03 billion, representing a 18.2% and 12% increase respectively over 2023.

- Seven countries contribute a total of ca. 74%, ranging from 5-16%
  - US, GE, UK, FR, IT, CA, SP

# Defense expenditures of NATO countries as a percentage of GDP 2023

- In 2023, Poland's defense spending as a share of gross domestic product was 3.9 percent, the highest of all NATO member states, followed by the United States at 3.49 percent. It is a target of NATO that every member country should spend at least two percent of their GDP on defense. As of this year, it is estimated that eleven of the alliance's 31 member states were meeting this target. The average expenditure on defense expenditure across all NATO member states was 2.64 percent in 2023, compared with 2.57 percent in the previous year.

# NATO Missions and Operations

**KOSOVO** - KFOR – 4500#, 27 nations, from 1999, safe and secure environment, support and coordinate the international humanitarian effort, civil presence, support the development of a stable, democratic, multi-ethnic and peaceful Kosovo,, support the development of the Kosovo Security Force

## **MARITIME SECURITY**

**Standing Naval Forces** = MARITIME GROUPS (2), MINE COUNTERMEASURES GROUPS (2), in Atlantic, Baltic, North Mediterranean, Black sea

**Sea Guardian** – Mediterranean, maritime security capacity-building, situational awareness and counter-terrorism, from Nov 2016

**Aegean Sea** – assist migrant and refugee crisis – from February 2016, NATO has deployed a maritime force to conduct reconnaissance, monitoring and surveillance of crossings

**Allies have also reaffirmed that Ukraine will become a member of NATO and agreed to remove the requirement for a Membership Action Plan. “This will change Ukraine’s membership path from a two-step process to a one-step process,” said the Secretary General, adding: “we will issue an invitation for Ukraine to join NATO when Allies agree that conditions are met.”**

# European Parliament

705 Members of European Parliament (MEPs)

- Sit by party, not nationality
- Only directly elected part of EU
- Elected to 5 year terms
- Seats appointed by MS' population

Political powers

- Approves appointment of Commission
- Censure/fire Commission




### Size of the political groups

## THE EUROPEAN COUNCIL

The European Council defines the EU's overall political direction and priorities and sets the EU's policy agenda. It usually adopts conclusions during European Council meetings which identify issues of concern and actions to take. It does not negotiate or adopt EU laws.



## Members of the European Council

The members of the European Council are the heads of state or government of the 27 EU member states, the European Council President and the President of the European Commission.



# The European Commission

Commission is the EU's executive arm and **runs the Union day-to-day**

- 27 Members (one per MS) – 5 year term
- **Has power of the purse**
- “Guardian of the treaties”
- **Significant power player internationally**
  - **Actions binding abroad (esp. in US)**
- **Will enforce any new Euro regulations**
- Commissioners are appointed by EU members, do not represent member states' views
- **Can negotiate and act on its own**

# 6 EU Commission priorities for 2019-24

1. Europe aims to be the first climate-neutral continent.
2. The EU's digital strategy will empower people with a new generation of technologies.
3. The EU must create a more attractive investment environment, and growth that creates quality jobs, especially for young people and small businesses.
4. The EU will strengthen its voice in the world by championing multilateralism and a rules-based global order.
5. *Europe* must protect the rule of law if it is to stand up for justice and the EU's core values.
6. We need to give Europeans a bigger say and protect our democracy from external interference such as disinformation and online hate messages.


# EU BUDGET 2024\*



The U.S. and European economies are deeply intertwined. According to U.S. Bureau of Economic Analysis data, the transatlantic economy—including the 27 EU member states and non-EU countries such as the United Kingdom (UK), Norway, and Switzerland—typically generates close to \$6 trillion per year in foreign affiliate sales and directly employs around 10 million workers on both sides of the Atlantic.

The United States and the EU are each other's largest overall trade and investment partners.

# **Munich Security Conference 2024**


**..almost 1,000 participants, among them 45 heads of state or government, represented 109 countries. Across 60 sessions in the main program, more than half of speakers were female and more than a quarter from the Global South.**

**Ukraine's President Volodymyr Zelenskyy saw the announcement of Navalny's death as a clear message to the leaders attending the conference. He stressed that Putin was waging a “war against any rules at all.” Zelenskyy issued an urgent call to remedy Ukraine's “artificial deficit” of artillery ammunition, long-range missiles, and air defense systems. The fall of Avdiivka to Russian troops during the conference weekend hammered the message of the impact of dwindling ammunition supplies home.**

## JOSEP BORELL - MUNICH SECURITY CONFERENCE – 2.18.2024

“And the most important events today are related to three geographical issues, which are: Ukraine, Gaza, and the Global South.

And the Global South - the third one. They have their own dynamic, but no doubt that the war in Ukraine and in Gaza has increased tremendously the political space of the Global South vis-a-vis us. And that we have to avoid ‘The rest against the West’.”

**This year, we gather amid an increased instability and conflict in the Middle East. We gather amid Russia's ongoing aggression in Ukraine, China's efforts to reshape the international order, transformative technological change, and, of course, the existential threat of the climate crisis.**

**In this context, I know that there are questions here in Europe and around the world about the future of America's role of global leadership.**

**These are questions the American people must also ask ourselves: Whether it is in America's interest to continue to engage with the world or to turn inward. Whether it is in our interest to defend longstanding rules and norms that have provided for unprecedented peace and prosperity or to allow them to be trampled. Whether it is in America's interest to fight for democracy or to accept the rise of dictators. And whether it is in America's interest to continue to work in lockstep with our allies and partners or go it alone.**

## China: Press remarks by High Representative Josep Borrell after concluding his visit to the country. OCT 15, 2023

... since the war in Ukraine, Europe has become a geopolitical power. We started being a trade power, after [being] an economic power. Now, **the war in Ukraine has converted us in a geopolitical power, not just an economic one and we want to talk with China from this approach. Do not look at the European Union relations through the lens of the relations with others.**

...for us Russia represents a huge threat for our security and that we are committed to support Ukraine facing the Russian invasion and asking China to take into consideration this very tough position from our side, **considering Russia as a security threat for the whole European Union.**

...we have to rebalance our economic bilateral relations. **We have a huge deficit that has increased 60% in the last years.** And this should not be the consequence of just a competitive disadvantage between the European Union and China.

## **BORRELL COMMENTS IN CHINA, CONTINUED**

But despite the differences, we believe that there is still a space for cooperation and **the most important challenges that the world is facing cannot be solved without a strong engagement with China.**

The first one is climate change. China is burning as much coal as the rest of the world together, in spite of the strong development of renewables in China's energy mix. **The increase of coal powered electricity production in China is offsetting the reduction in the rest of the world. So, [there is] no way of solving the climate change problem without a strong engagement and partnership with China.**

We can say the same thing about the level of debt of the emerging countries and the possibility of having a new debt crisis on the way. We have to look at that because **China has become the biggest creditor of the emerging economies.**


