

U.S. Department of State



Purpose: The Department of State exists to assist the President, through the Secretary of State, in formulating and executing the <u>foreign policy and</u> <u>relations</u> of the United States. The State Department is the lead agency within the U.S. Government on foreign affairs.

Mission: To protect and promote U.S. security, prosperity and democratic values and to shape an international environment in which all Americans can thrive. *This is a national security mission.*



Places: 273 bilateral posts (embassies and consulates) in 175 countries, along with 11 permanent missions to international organizations

People: ~14,500 Foreign Service, ~ 11,000 Civil Service, ~50,000 Locally Engaged Staff, ~2300 family members -- 3% of total DoD workforce




